Ampine LLC's CARB executive order N-17-143 was uploaded on August 31, 2017 in the EPA CDX database and assigned Unique Form ID TPC-RTA-3657. Hence, Ampine LLC's particleboard (Apex and Encore) panels comply with EPA TSCA Title VI via 40 CFR 770.17 *No-added formaldehyde-based resins* which states:

*(a) Producers of composite wood product panels made with no-added formaldehyde-based resins may apply to an EPA TSCA Title VI TPC **or CARB** [Emphasis added] for a two-year exemption from the testing requirements in 770.20 and certification requirements in 770.15 and 770.40(b).*
